A business plan may also serve as a tool to help raise money and is usually required to apply for a loan to attract financial capital.

# **Determine Your Business Structure**

It is important to determine the structure of your business for operating and business reporting purposes. Will you operate your business as a sole proprietor, partnership (2 or more owners), or corporation (1 or more stockholders/officers)?

If you are a sole proprietor, no formation documents are required to be filed with the Secretary of State. It is optional for partnerships to file with the State.

If you are starting a corporation or a limited liability company, you must contact the California Secretary of State's Office. They can supply you with all the information and forms you need.

You may also want to consult an attorney or Certified Public Accountant (CPA) for more guidance.

Woodland Business Prospector speeds up and simplifies the process of finding the optimal location for a business in Woodland by providing public access to a range of valuable information.

The website, **www.woodlandprospector.com**, is a free interactive economic development mapping program that provides enhanced economic development and site selection services to the business community, retail, commercial, and industrial properties in Woodland.

This website allows users to search for available commercial buildings and sites as well as generate site-specific demographic and business analysis reports.

If you cannot find what you are looking for, staff in Economic Development is eager to help. Feel free to contact them at (530) 661-5921.

# Helpful Hint: Check and Clear Zoning Regulations!

Before signing a building/property lease or purchase agreement, contact the City of Woodland's Community Development Department to determine the zoning of the site.

Not all spaces are suitable for certain types of business uses. City zoning exists to protect you and your neighbors from incompatible uses. For example, it may not be safe for a childcare center to be located next door to a chemical manufacturing plant and zoning restrictions help avoid this potential hazard.

Planning Division staff will determine if your business is a permitted use for the location and if any special approvals are needed. Be sure to call the Planning Division at (530) 661-5820.

If you create a name for your business that is different than its legal name, you need to register the business name with Yolo County. This step needs to be completed *before* obtaining a Business Registration (License) from the City of Woodland.

Also, public notices announcing your new business name must be posted for four (4) weeks in the local newspaper to complete the registration process.

# Helpful Hint: Deciding Your New Business Name

To make sure your business name does not conflict with other businesses, you can check to see if it is in use within Yolo County by checking the Fictitious Business Name Database at www.yolorecorder.org

# Tax Reporting

Social Security (800) 772-1213 www.ssa.gov/employer All businesses are required to file both state and federal tax returns. Please contact the State Franchise Tax Board and the Federal Internal Revenue Service to learn more about specific requirements.

Will you sell a product? The California Board of Equalization can assist you in determining whether you need a Seller's Permit. You may also be required to collect sales tax. To do so, the Board of Equalization will need to issue you a resale number in order to report that sales tax.

Whether self-employed or an employer with one or more employees, you must also pay Social Security taxes.

# YOU NEED A LICENSE TO OPERATE A BUSINESS

The City of Woodland uses the term "business registration" rather than "business license." The application fee is determined by the type of business: commercial, out of town, home based, temporary, and special events (special events are processed through the Police Department). The business registration is renewable at the end of one year and the fee is dependent on the number of rentals, gross receipt or the number of employees. Registration fees start at \$353 for new businesses; renewal ranges from \$54 to \$796 based upon gross receipts and/or number of employees.

Home-based businesses are also required to apply for a business registration (license); fees start at \$80. In addition, businesses that are located outside of the city limits of Woodland, but doing business in Woodland, such as vendors, consultants, and contractors are required to apply and pay for a Woodland business registration (license). Registration will need to be renewed annually.

Your business may require site inspections by the Fire, Building and/or Police Department as part of your application approval, depending on your business type and/or if you are making improvements to a building.

## Alarm Permits

If your business operates a burglar alarm system it must obtain an Alarm Permit from Woodland Police Department.

## Building Permits

Building Permits are how the City of Woodland ensures construction is safe for occupancy and use. A Building Permit is needed for all new construction in Woodland. Your business must be located in a building constructed appropriately for the use.

## • Fire Code Permits

A Fire Code Permit from the Woodland Fire Department is required if you want to conduct specific activities and practices. Use of hazardous substances or materials may require additional review, permits and/or inspections.

# • Sign Permits

If your business would like to display a sign that is visible from outside a building, sign design approval and/or permit is required from the Community Development Department. Permits are needed for both permanent and temporary signs; such as on a building, window signs, and banners.

US Customs Customs Boarder Patrol www.cbp.gov Depending on the type of business, you may be required to obtain permits or licenses from the following County, State, or Federal agencies. Please contact these individual agencies directly if applicable.

**Alcohol Beverage Control (ABC) License:** No person may directly or indirectly, under any pretense, sell, barter, charge for possession or otherwise dispose of alcoholic beverages as part of a commercial transaction without having obtained the proper license or permit.

California Department of Consumer Affairs License: Many professional businesses such as accountants, engineers, doctors, and dentists require a State license from the California Department of Consumer Affairs. Businesses such as barbers, cosmetologist, security services, and auto repairs are also required to obtain a State license. Please call to find out if you must register your business.

**Import/Export Permit:** If your business will involve the import or export of products with other countries, you may need to obtain an Import/Export Permit. (*see U.S. Customs*)

U.S. Customs (CBP): Information is provided concerning S m a 11 Business Program CBPrequirements. Also provided are efforts used to increase participation and to provide maximum practicable opportunities in CBP acquisitions to small business, service-disabled veteran-owned small business. veteran-owned small business, Historically Underutilized Business Zones "HUB Zone" small business, small disadvantaged business, and women-owned small business concerns.

**Restaurants, Food Vendors, Salons and Tattoo Parlors:** A health inspection is required for restaurants and food vendors, as well as salons and tattoo parlors. Contact the Yolo County Environmental Health Department to arrange for an inspection, or to request advice regarding health and environmental safety issues.

**Retail and Wholesale Business Permits:** If your business will involve sales, you will need to obtain a Seller's Permit from the State Board of Equalization.

Child Care Center of Family Child Care Home Licenses: Licensing of all child care centers and family child care homes in California is required and can be obtained through the California Department of Social Services. In addition, large family day care homes with greater than 15 children require Planning Division review and a Business Registration and would be treated as commercial business.

Additional Expenses to Consider: Account; banker; attorney; insurance Agent/Broker; and worker's compensation

# Helpful Hint: Opening a Restaurant

If you plan to build or remodel a food facility, it is necessary to submit two sets of detailed plans and specifications to the Yolo County Environmental Health Department.

These plans must be approved before you begin work. Call (530) 666-8646 to speak with an Environmental Health Specialist about the process and for Food Facility Plan Check Guidance.

Contractor's License: Construction is one of the largest industries in California's diverse economy. The Contractors State License Board (CSLB) receives and processes applications for new licenses, additional classifications, changes of license records, and license renewals. An Application for Original Contractor's License can be obtained from any CSLB office, by telephone, or online.

**ADA Information Line:** The ADA Information Line provides information and technical assistance on the ADA Standards for Accessible Design and other ADA provisions applying to businesses, non-profit service agencies and state and local government programs. Information Specialists are available to answer general and technical questions during business hours on weekdays. The Information Line also provides 24 hour automated service that delivers technical assistance (800) 514-0301.

Other Permits & Licenses: To determine what other regional, state, and federal permits and licenses your business may need, call the State's "CalGOLD Business Permits Made Simple" office.

# Helpful Hint: Becoming a Contractor

When testing for your Contractor's License, be sure to study beyond what you need to pass the test. Continue upgrading your skills in your craft and in business matters. The SBA provides you with a wealth of information unique to small business through monthly chat events, electronic newsletters, podcasts and a myriad of business resources to support your business needs. The Northeastern California Small Business Development Center (NECSBDC) is funded to provide loan planning assistance for SBA loans

**Business Attraction:** Economic Development (ED) is the first point of contact after finding a real estate broker that is familiar with the community. ED will provide related site information, propose alternative suitable sites, utility information, plans for the area, provided fee estimates, participate in site tours and on occasion travel to the other company centers or headquarters for meetings.

**Business Incentives:** Based on the type of business and your demands the city may be able to provide incentives for the expansion or startup of your business. Contact ED for more information.
