Links to lists of eligible controllers can be found at www.cityofwoodland.org/rebates. We strongly recommend that you hire a landscape contractor certified by the Irrigation Association (IA), California Landscape Contractors Association (CLCA), and/or an EPA WaterSense program partner to install your WBIC. </p>
