AND WHEREAS, THE UNDERSIGNED ACKNOWLEDGES THAT THE WORK AND ACTIVITIES OF SAID DEPARTMENT ARE INHERENTLY DANGEROUS AND INVOLVE POSSIBLE RISK OF INJURY, DAMAGE, EXPENSE, OR LOSS TO PERSON AND PROPERTY, THE UNDERSIGNED FURTHER AGREES THAT SAID DEPARTMENT DID NOT TAKE THE INITIATIVE IN EXTENDING AN INVITATION TO RIDE ALONG OR ACCOMPANY ITS MEMBERS.

NOW THEREFORE, BE IT UNDERSTOOD THAT THE UNDERSIGNED HEREBY AGREES THAT THE CITY OF WOODLAND, THE WOODLAND POLICE DEPARTMENT, ANY MEMBER OF THE DEPARTMENT, THE DRIVER OR OWNER OF ANY AUTOMOBILE OWNED OR OPERATED BY, OR IN THE SERVICE OF THE CITY, THEIR SURETIES, AND EACH OF THEM, SHALL NOT BE HELD LIABLE OR RESPONSIBLE UNDER ANY CIRCUMSTANCES WHATSOEVER BY THE UNDERSIGNED, HIS/HER ESTATE, OR HEIRS, FOR ANY INJURY, DAMAGE, EXPENSE, OR LOSS TO THE PERSON OR PROPERTY OF THE UNDERSIGNED INCURRED WHILE RIDING AS A GUEST OR OBSERVER IN THE WOODLAND POLICE DEPARTMENT VEHICLE OR WHILE ACCOMPANYING A MEMBER OF SAID DEPARTMENT DURING ACTIVE PERFORMANCE OF THEIR OFFICIAL DUTIES AS A PEACE OFFICER.
